## COMMITTEE REPORTS

**SECURITY-** Officer Bratton was present for the meeting and reviewed the Security report. He noted traffic violations have increased and illegal dumping remains an issue along Old Riley Fuzzel Road.

Mr. Fleming then discussed increasing Holiday Patrol security. Mr. Stewart motioned to approve the increase, seconded by Mr. Gourley and carried.

YARD OF THE MONTH- The Christmas Lighting Contest will take place December 17<sup>th</sup> at 7pm.

**TODDLER PARK-** Mr. Gourley will examine the gate latches to ensure they are working properly.

**POOL-** Mr. Stewart advised the AC Unit in the Clubhouse will need a new drip pan, and will get bids to replace ceiling tiles and paint upon completion of repairs. Once the new fence is installed to enclose the splash pad, Mr. Stewart will inquire to add shade screens to the splash pad fencing.

After reviewing Southwest Pool Contract Bid, Mr. Fleming motioned to accept it, seconded by Mr. Stewart and carried. Ms. Ferris will send a cancellation letter to Blue Water Pools, effective December 16<sup>th</sup>, and a start date of December 17<sup>th</sup> for Southwest Pools.

The Board discussed resurfacing the rear parking pad behind the Clubhouse. The Board agreed to table the issue until Mr. Gourley contacts the pipeline company.

**GROUNDS-** Mr. Fleming announced all plants in need of replacement will begin tomorrow.
